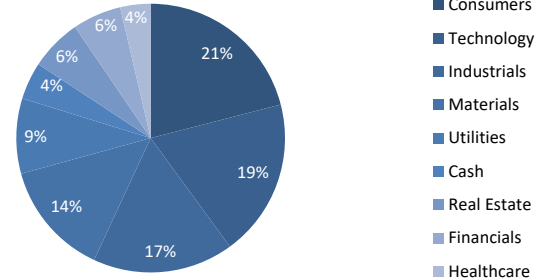




Profile and investment policy

The GFH European Equity Transition Fund (GFH Europees Aandelen Transitiefonds; "Fund") is particularly suitable for private investors with an investment horizon of at least ten (10) to fifteen (15) years. The objective of The Fund is to achieve returns through a balanced mix of European diversified equity and liquidities. In addition, the Fund can invest in alternative investments, e.g. through other collective investment schemes. The Fund has an average target return of 7% per year. The Fund invests primarily in European equities or similar instruments traded on a regulated market or any other market in financial instruments. The investments are spread over at least 20 individual securities and similar instruments. No specific distinction is made according to geographical origin or the economic sector. A potential currency risk can be hedged.

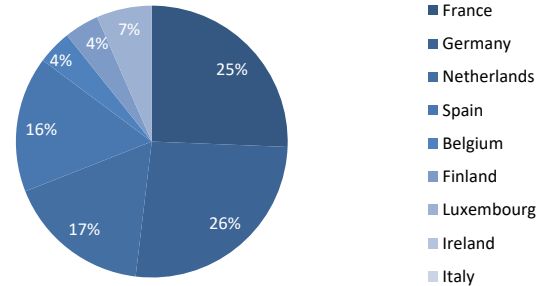
Asset allocation by sector

Asset allocation by country



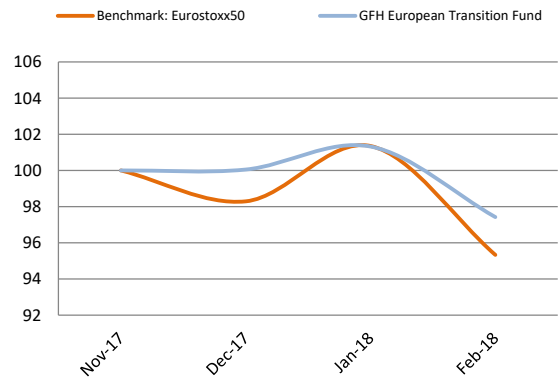
